04/27/2021	Labor	Executive Order	No	<a href="#">Raises the minimum wage of federal contract workers</a> to \$15 an hour in early 2022, up from the current \$10.95. Eliminates the tipped minimum wage, \$7.65 an hour, by 2024. Requires a \$15 minimum wage for federal contract workers with disabilities.
04/16/2021	Immigration	Memo	Yes	Reverses the Trump policy banning refugees from key regions and enables flights from those regions to begin within days. <a href="#">Declares that the 15,000 annual refugee cap set by Trump will be raised</a> to a number to be determined by May 15.
04/09/2021	Other	Executive Order	No	Forms the Presidential Commission on the Supreme Court of the United States, which is intended to provide an analysis of the principal arguments for and against Supreme Court reform.
04/01/2021	Other	Executive Order	Yes	Revokes a Trump executive order that authorized sanctions on International Criminal Court officials

03/07/2021	Equity	Executive Order	No	Directs each agency to evaluate and submit a strategic plan within 200 days on opportunities to <a href="#">promote and expand access to voter registration and participation</a> ; directs the General Services Administration to modernize and improve <a href="#">vote.gov</a> ; calls for strategies to expand policies allowing federal employees time off to vote and to expand employees’ ability to serve as nonpartisan poll

02/24/2021	Immigration	Proclamation	Yes	Revokes a Trump-era proclamation that limited legal immigration during the Covid-19 pandemic
02/24/2021	National Security	Executive Order	No	Launches a 100-day review of US supply chains for pharmaceuticals, critical minerals, semiconductors
